Issues Fixed

CRM:

- Autotask: The list name will also get pushed with the to-do description to the to-do description field in Autotask.
- ConnectWise & Autotask: Provided the checkbox for setting of Opportunities/Contact 'Created On' date to be the same as the date on which it was created in the CRM, when importing the contact from the CRM
- ZOHO: Implemented Organization domain sync for Partner Registration.
- Implementation of User Pull and Push For Hubspot CRM has been done.

Dashboards:

- Provided Videos for the Dashboard Banner widget.

Drips:

- In Nurturing drip, the "Copy" option is missing for users with copy permission. This has been fixed.

Editors:

- Provided navigation in 'edit' questions of the Certification template.
- Provided the "Created On" and "Updated On" fields on the hover of templates in the "Compose Email" step.
- Email Media: CTA Text color was not taken as per the style applied when viewed in Outlook. This has been fixed.
- 'My Favorites' : Assets deletion will not depend on any permission.
- Certification Template: When back navigation was used, the question detail was not saved. This has been fixed.
- Input Questionnaire Fields in Editor: Creation of Groups and sub-groups for the set of fields implemented.
- Certification template changes were reverted when the template was saved without making changes to the template. This has been fixed.

**Exports:**

- Column values shifted and the "Completed" field was not exported for the User-wise Certification report. This has been fixed.

MDF:

- When a request was saved in the Reimbursement request folder and Partial request folder, then the request was moved to the New request folder. This has been fixed.

Notifications:

- Provided the option to send the email notification of Incentive assignment to all assigned users or to newly assigned users.

Reports:

- Added "Completion Date" in the Certification report.
- Added "Completion Date" in the Course and Curriculum reports.

Social Posts:

- Social Drip: Provided the option to lock editing/creating/deleting messages at the template level for the created media.
- In Social drip templates, validation of a single message will be for "Regular Post" or "Specific Day".

Site & Link Tracking:

- Provided Partner Admin to configure the tracking link as Public for Organization level.

Scoring & Lists:

- User list, User Scoring condition of 'Unsubscribed from Company Emails' implemented.
- Provided notification action for Asset lists.
- "Email Sent On" and "Contacts Created On" conditions for Users and Organization Lists, User Drip conditions, and User Scoring were implemented.
- Provided the columns of "Shared" and "Notification" for the Company Contact List.
- Provided User Origin and User Created by, fields in the User Smart list, Organization Smart list, User Drip, and User Scoring conditions.

Setup:

- Organization overview page modifications are complete.



Usability:

- Sales Playbook: Provided help info on the playbook page when no contacts are added instead of displaying the modal window of "Add Contacts".

UI:

- The UI issue on the Export page has been fixed.

View Assets:

- If "Include customized assets" is checked in the "My Favorites" folder, it will now display all the Media and bookmarked templates.
